EQUIPMENT RENTALS AND HAULING CHARGES

Container size is 30 cubic yards. Dimensions are 8 ft. wide X 6 ft. High X 23 ft. long. This service is **not** for extremely heavy loads. Maximum Payload may not exceed 6 tons. Payloads in excess of 6 tons will be invoiced at a rate of \$44.20/ton. Hazardous Materials, Tires and otherwise dense and heavy materials are not allowed. The container must not be filled above the top lip. All Open Top Pick Up Requests Must Include Container Number.

CWD will haul the equipment to an approved landfill within the North Texas Municipal Water District and dispose of the Class I Refuse. When the container is no longer needed, the customer must specify when calling in for service that CWD is to pick up and keep the container. Otherwise the empty Open-Top will be returned.
