3. There is an option to listen to the meeting through the audio on your computer, or alternatively an option to call the telephone number below to listen by telephone audio. Select your preferred option when you log into the meeting.
4. You will enter the Zoom meeting once the steps above are completed. Attendees that log into the meeting through their computers will be able to view presentations and video interactions. Attendees that dial in using their telephone will only be able to hear the audio of the meeting.
