All swimming pools and spas must pass an annual inspection. before a Health Permit is issued. Once this Health Permit application is submitted, please call the Environmental Health Division to schedule an inspection at 214.509.4180. The Certified Pool Operator must be present for the inspection.

Pools and spas may not open for use until the inspection is passed and the Health Permit is issued.
